



## RULES OF THE DRAW 'FREE RENTAL WEEK'

### **1. Organising entity and purpose of this prize draw**

This promotional activity will be organised by TALLERES MARTÍN SL (hereinafter ESPACAR), with C.I.F. B29076270, with registered office at CTRA CADIZ, NUM. 163 29680 ESTEPONA - (MALAGA), and has the purpose of allowing rent a car customers to participate in the draw 'FREE WEEK RENTAL' which is regulated by the following rules and whose participation is developed for promotional purposes. These promotional rules will be available at [www.espacar.com](http://www.espacar.com) and must be complied with by the participants in order to be able to enjoy the prize if they are the lucky winner(s).

### **2. Users of the competition and mechanics of participation**

The competition is open to **all persons over 25 years of age and resident in Europe**, who make an online reservation between **20 March and 30 April 2025** for a car rental, for 7 or more consecutive days, **for the period from 5 May to 31 July 2025** and provided that the user has not cancelled the reservation before **5 May**.

These users automatically participate in the competition when making the reservation, and it is not necessary to register or provide any information other than that previously collected to formalise the reservation for the rental.

Under no circumstances will anyone under 25 years of age or who for any reason have been legally incapacitated be allowed to participate.

Employees of TALLERES MARTIN SL, as well as their relatives within the first degree of consanguinity or affinity, will be excluded from participation.

Persons who do not meet these conditions will not be able to participate in the draw and will be disqualified from it.

### **3. Date of the competition**

This competition will be active **from 20/03/2025 to 30/04/2025**, both inclusive, until 23.59 hours on the closing date (Peninsular time). The draw will take place on **Monday 5 May 2025** by means of the simple random draw option of the sortea2 platform ([www.sortea2.com](http://www.sortea2.com)) choosing 1 winner and 2 alternates.

### **4. Prize**

The prize consists of a free week's car rental with Espacar Rent a Car, to be enjoyed between **May and July 2025**. There will be only one winner and only one draw.



When the draw is made among users who have already made a minimum 7-day reservation, the prize will consist of the corresponding payment (or non-payment) of the amount corresponding to the first 7 days of the reservation, applying the same rental conditions that were specified in the reservation prior to the draw (model, location, etc.).

In the event that a user with a booking of more than 7 days is the winner, the first 7 days will also be credited (or not charged), without prejudice to the charge for the remaining days, provided that the first 7 days are between the months of **May to July 2025**.

The winner will be chosen according to the following procedure:

1. ESPACAR will proceed by means of a random draw that will result in 1 winner and 2 substitutes.
2. If the winner is disqualified for not meeting the requirements previously established in these rules, he/she will not be entitled to the prize and it will be awarded to the next participant chosen as a substitute, and so on until the third substitute is chosen, if necessary.
3. ESPACAR will not be obliged to inform the participant(s) from whom the prize is withdrawn, only the winner who finally meets the required conditions.
4. The winner will be informed by e-mail to the e-mail address in our database and/or by telephone whenever possible.
5. If the winner does not provide the information or documentation that may be required by ESPACAR, or does not fulfil the requirements of these rules to be a participant and winner, even though he/she has been announced as the winner or chosen in the draw, the prize will be assigned to the first substitute who fulfils all the conditions of these promotional rules of the draw.
6. The prize cannot be exchanged for any other gift or exchanged for cash.

## **5. Communication of the prize**

**ESPACAR will publish on its website [www.espacar.com](http://www.espacar.com) the promotional rules of this prize draw.** The name of the winner and the dates of the prize will also be published on the website and on the company's social networks, once it has been confirmed that he/she fulfils the conditions to be a participant and, therefore, that he/she is the winner, provided that the company confirms acceptance of the prize with him/her.

In the event that for reasons beyond the company's control it is impossible to contact the winner **within 48 hours** of the draw taking place, or if the winner expressly and reliably renounces the prize within this period, the participant chosen as the first substitute will be contacted, and so on.

ESPACAR may ask the winners for **any information or documentation** to accredit that they fulfil the conditions to be a participant and therefore a winner, and in the case of not providing this information, they will be disqualified. This information may be requested by e-mail to the address provided by the participant, and the winner will have two (2) calendar days from the sending of the



e-mail to provide it. Winners who do not provide the requested information or documentation, or who after verification do not comply with any of the conditions to be participants or winners, will be disqualified, and the prize will be assigned to the next chosen substitute, in which case ESPACAR will not be obliged to communicate with the participants who have lost their right to the prize.

ESPACAR may request and publish **photographs** of the winner and his/her companions, both before and during the enjoyment of the prize, **for publication on ESPACAR's social networks**. This last condition is indispensable in order to be able to enjoy the prize, given that this draw is carried out for promotional purposes and to disseminate ESPACAR's activity.

## **6. Responsibility of the company**

ESPACAR is not responsible for any damages or losses that may occur while the winner is enjoying the prize, nor for cases of force majeure that may prevent the winner from enjoying the prize.

ESPACAR is exempt from any responsibility in the event of any error in the data provided by the participants that would prevent their identification and thus their participation.

ESPACAR reserves the right to eliminate from the draw for justified cause any user who defrauds, alters or renders useless the proper functioning and the normal and regulated course of the draw and its conditions.

## **7. Processing of personal data**

By participating in this prize draw and accepting the prize, the winner of the prize authorises TALLERES MARTIN SL to use the personal data, including the image, for the purpose of communicating and disseminating the name of the winner and the company through its media, website, social networks and similar without the right to any compensation whatsoever.

By accepting these rules, the participant freely consents to the processing of his/her data for the purposes for which he/she has been informed.

## **8. Applicable law**

For everything that is not specified in these legal bases of this raffle, the promotion will be subject to the Spanish regulations in force at the time.

In the event of litigation, the dispute will be resolved by the Courts and Tribunals of Estepona (Malaga), without prejudice to the jurisdiction that may correspond according to the applicable regulations.

## **9. Acceptance of the rules of this competition**



The simple participation implies the acceptance of the present promotional rules, so that the manifestation in the sense of not accepting all or part of them will imply the exclusion of the participant and as a consequence of this, ESPACAR will be released from the fulfilment of any obligation contracted with the participant with respect to this promotion.
